The refund will be issued less the shipping cost of the return. Refunds are issued less S&H (shipping and handling charged at the time of purchase) and a \$5 restocking fee per order. A refund will be provided for only the bottles actually returned. A prorated refund will be issued if the entire purchase is not returned. Refunds will be issued within two weeks of the return arriving in our Home Office.

Bulk Orders
